2. The Tenderer **MUST** be registered with at least one of the CIDB categories : G4, ME, E02, E03 or E04 (For Tender No. 1)
3. The Tenderer **MUST** be registered with at least one of the CIDB categories : G5, G4, ME, E02, E03 or E04 (For Tender No.2)

1. Interested Tenderers are invited from experienced Companies with the specified qualification details as per the above.
2. For Briefing and Site Visit session, all Representatives from the interested Tenderers shall fulfil the following **MANDATORY** requirements:
