- Interested Tenderers **MUST** be a **G7 Contractor registered with CIDB** under M&E Category with Sub-category: E01 ("Sistem Bunyi") AND registered with MoF Malaysia.
- Tenderers **MUST** submit a proposal on the design and development of the PA system architecture.
- Tenderers **MUST** comply with the following Financial requirements:
 - Submission of the last three (3) consecutive years of signed Audited Financial Statements lodged with SSM in compliance with the Companies Act 2016
 - Minimum Share Capital of RM10,000.00
 - Positive cumulative EBITDA for the last three (3) consecutive years
 - Positive Shareholders' Fund in the latest Audited Financial Statement.
 - Minimum Tender Funding Capacity $\geq 5\%$ of the tender value quoted
- Interested Tenderers are invited from experienced Companies with the specified qualification details as per the above.
- For Briefing Session and Site Visit, all representatives shall fulfil the following criteria:
 - Limited to two (2) representatives with sound knowledge of Tender & Contract for the above-mentioned works. The representative **MUST** be duly authorized by the Company.
 - Wear Personal Protective Equipment (jacket, helmet and shoes) for Site Visit; and Prasarana **WILL NOT** entertain any Tenderer's request that does not meet all the Mandatory requirements listed above.
